## Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement

**Waiver:** In consideration for the participant to be allowed to participate in NPC Soccer or NPC Futsal Club events, practices, trainings, camps or games at any facility or field used by NPC Soccer or NPC Futsal Club, for myself, for Participant and for Participant's heir, family, personal representatives and/or assigns (collectively the "Releasees"), do hereby release, waive, discharge and agree not to sue NPC Soccer, NPC Futsal Club and all other partners, stockholders, officers, directors, employees, agents, affiliates and sponsors, collectively, the "Released Parties", from all present and future claims for property damage, personal injury, acts of God or wrongful death arising as a result of Participant's participation in the events, practices, trainings, camps or games. I understand and agree that the Released Parties are not responsible for any injury or damage arising out of the events, practices, trainings, camps or games, **even if caused by Released Parties Negligence.**

I represent that I understand the nature of the events, practices, trainings, camps or games and that the Participant is qualified, in good health, and in proper physical condition to participate. I acknowledge that if I believe events, practices, trainings, camps or games conditions are unsafe, I will immediately discontinue Participant's participation in the events, practices, trainings, camps or games.

**Severability:** I understand that this document is intended to be as broad and as inclusive as permitted by the laws of the state in which the events, practices, trainings, camps or games are taking place and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. I further agree that any legal proceedings related to this waiver will take place in Alexandria, VA.
